

Ohio ACEP Privacy Policy

Ohio ACEP respects the privacy of its members and other visitors to its Web site. To protect online privacy, Ohio ACEP has implemented the following policy.

This policy is effective as of June 3, 2025. If our privacy policies change, notice of the changes will be placed on the Web site.

What Information Does Ohio ACEP Collect? Most data Ohio ACEP collects are used only to help us better serve our members and other Web visitors. It is our general policy to collect and store only personal information that our members, customers and visitors knowingly provide.

From General Users. Ohio ACEP does not collect any personal information from users browsing its Web site. Only aggregate data -- such as the number of hits per page -- are collected. Aggregate data is only used for internal and marketing purposes and does not provide any personally identifying information.

From Ohio ACEP's Members, Conference Registrants, and Other Customers. To register for a conference, purchase a product or make an Ohio ACEP PAC donation, members and other users are asked to register and provide some limited information. This information is submitted voluntarily. Ohio ACEP asks users to provide their name, phone, mail and e-mail addresses. Similar information may be submitted to ACEP through membership applications, conference or seminar registration, publication orders, subscriptions, surveys and contest registrations.

Additionally, for some e-mails sent in HTML format by Ohio ACEP to its members through its listservs and electronic newsletters, we will collect specific information regarding what the recipient does with that email. For those email messages, Ohio ACEP will monitor whether a recipient subsequently clicks through to links provided in the message. Other information collected through this tracking feature includes email address of a user, the date and time of the user's "click," a message number, name of the list from which the message was sent, tracking URL number and destination page. Ohio ACEP only uses this information to enhance its products and distribution of those products to its members. This information is not sold or distributed in any other manner.

How Does ACEP Use Data Collected? Ohio ACEP uses information voluntarily submitted by members and other customers in the following ways:

Ohio ACEP Member Services and Products. Generally, Ohio ACEP uses data collected to improve its own web content; to respond to visitors' interests, needs and preferences; and to develop new products and services. Additionally, personal information may be used to communicate with you about upcoming events, programs and opportunities or provide you with updates and newsletters.

Disclosures to Third Parties.

On occasion, Ohio ACEP may provide limited data to third parties that offer products and services. This limited data includes names, job titles, and preferred mailing addresses, but does not include phone numbers or e-mail addresses. Users may request Ohio ACEP refrain from disclosing contact data to third parties by contacting Ohio ACEP info@ohacep.org.

Credit Card Account Information. Ohio ACEP does not store credit card account information provided by its members and customers. When members and customers choose to pay using their credit cards, Ohio ACEP submits the information needed to the payment processor.

How Does Ohio ACEP Use Cookies? Our web site may use cookies and similar tracking technologies to improve your browsing experience and gather information about how you use our site. You can control the use of cookies through your browser settings.
