# Documentation and Coding Psychiatry & Behavioral Health Care 2023

## Updates on Outpatient E/M and Therapy Services

### Activity Type

On-demand Webinar (Enduring Material)

### Overview

This 90-minute program covers the changes in Medicare (CMS) and Medicaid rules for how care and services are delivered and paid for. This includes the update on "incident to services." A review of the changes in CPT coding highlighting office/outpatient E/M services. A review of specific mental health issues as well as therapy services are part of this process. A quick review of ICD 10 coding for the social determinants of health and more.

### Learning Objectives

- Describe the basic Medicare and Medicaid changes including the changes in timing of some services (office to facility), role of mid-level providers in care and changes in incident to billing.
- Explain telehealth documentation, coding and permitted services in 2023 with a review of the changes in "across state line" care.
- Describe the Evaluation and Management documentation and coding changes made in 2021 including the updates in problem category, data review and time-based coding for 2023 (outpatient/office).
- Explain the psychiatry coding rules for diagnostic assessment and therapy performed by the medical providers for CPT codes 90792 and therapy codes as well as a discussion about interactive complexity.
- Understand diagnoses coding and psycho-social determinants of health.
